



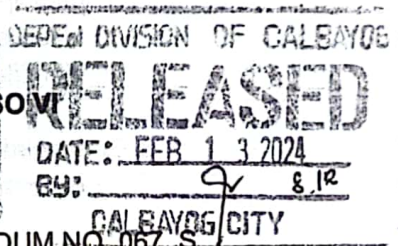

1. Attached herewith is the corrected and final list of participants to the 20th ASEP Quest 2024 on February 23-25, 2024, Teachers Camp, Baguio City.
2. The registration fee of student-contestants (1<sup>st</sup> and 2<sup>nd</sup> placers from public and private schools) in the amount of Two Thousand Pesos (P2,000.00) shall be taken/reimbursed from SEF fund, and other LGU source of funds. The remaining amount of One Thousand Eight Hundred Pesos (P1,800.00), and transportation /travelling expenses, and other incidental expenses shall be borne personally or shall be taken from PTA Fund, Math Organization, Science Organization, YES-O Organization, or other source of funds, subject to usual accounting and auditing rules and regulations. Hence, no amount shall be charged to school MOOE for student-contestants.
3. The registration fee of division delegation officials/division personnel, employees, and staff participants in the amount of Two Thousand Pesos (P2,000.00) shall be taken/reimbursed from SEF fund, and other LGU source of funds. The remaining amount for the Registration fee amounting to One Thousand Eight Hundred Pesos (P1,800.00), and the transportation /travelling expenses and other incidental expenses shall be charged against

local / division MOOE, subject to usual accounting & auditing rules and regulations.

4. While the full registration fee amounting to P3,800.00 for school heads, teacher-contestants, teacher-coaches and other identified teacher participants, and the transportation/travelling expenses and other incidental expenses shall be charged against School MOOE, subject to usual accounting & auditing rules and regulations.
5. This Memorandum shall serve as Travel Authority for student-contestants, teacher-contestants, teacher-coaches and other identified teacher participants and school heads which are not included in the list of delegation officials. A separate travel authority shall be made and issued to the identified delegation officials.
6. Immediate dissemination of and compliance with this Memorandum of all concerned are desired.
