STRICT IMPLEMENTATION OF THE "GUIDELINES IN THE IMPLEMENTATION OF THE SAFE SPACES ACT IN BASIC EDUCATION INSTITUTIONS" IN ALL PUBLIC AND PRIVATE SCHOOLS

- 1. Pursuant to Memorandum OM-OUOPS-2024-05-01115 (copy hereto attached) dated January 12, 2024, providing Guidelines on the Implementation of the Safe Spaces Act in Basic Education Institutions, all schools are hereby directed to observe strict compliance to the said Guidelines.
- 2. This office emphasizes the duties and responsibilities of the schools as provided in the abovementioned guidelines, as follows:
 - a. Disseminate or post a copy of the *Guidelines* in a conspicuous place in the educational institution:
 - i. sending copies
 - ii. posting a copy online
 - iii. Conduct orientation to teachers and students
 - b. Provide measures to prevent GBSH
 - i. information campaign
 - ii. express inclusion in the student handbook
 - iii. orientation of student organizations
 - iv. training of teaching and non-teaching staff, students, security officers, and other members of the school community
 - c. Create a Committee on Decorum and investigation (CODI)
 - d. Provide and disseminate, in consultation with all persons in the educational or training institution, a code of conduct or school policy which shall:
 - i. expressly reiterate the prohibition on GBSH

- ii. prescribe procedures of the internal mechanism
- iii. set administrative penaltics
- Designate an office or person to receive complaints of sexual harassment
- 3. Section 20, Rule VI of the *Guidelines* requires that a Committee on Decorum and Investigation (CODI) be created in schools, and that for its implementation, the existing Child Protection Committee (CPC) established in DepEd Order 40, s. 2012 shall also be the Committee that will handle GBSH cases in the public and private schools. The committee shall be composed of the following:
 - a. School Head/Administrator: Chairperson
 - b. Guidance Counselor/Guidance Designate: Vice-Chairperson
 - c. Representative of the Teachers as designated by the Faculty Club
 - d. Representative of the Parents as designated by the Parents-Teachers Association
 - e. Representative of the Students as designated by the Supreme Elementary and Supreme Secondary Learner Government (SELG/SSLG)
 - f. Representative from the Community as designated by the Punong Barangay, preferably a member of the Barangay Council for Protection of Children (BCPC). For private schools, a representative from the community provided in the preceding number shall be optional.
- 4. For the updated list of the CODI/CPC members, all schools are directed to submit the directory of their CODI/CPC composition thru the following link:
