DECLARING DENGUE OUTBREAK IN THE CITY OF CALBAYOG

WHEREAS, the Regional Epidemiology and Surveillance Unit (RESU) has reported that Eastern Visayas had 7,145 dengue cases from morbidity week 1 to 32 for this year which 187% higher than the same period last year with 2,487 cases of dengue

WHEREAS the Regional Epidemiology and Surveillance Unit has also reported a total of 290 cases from morbidity week 1-32 for Calbayog City for this year and when compared with the same period of last year (84 cases) is 245% higher. (ANNEX a)

WHEREAS, the incidence of dengue in Calbayog City for morbidity week 29 (23 cases of dengue) has been doubled in morbidity weeks 30 (49 cases), 31 (47 cases), 32 (49 cases) and was observed to be in plateau for 3 weeks based on the *hospital surveillance reports and community-based surveillance reports combined*. (ANNEX b)

WHEREAS, the incidence of dengue is continuously rising and has gone beyond the alert and epidemic threshold set for the city by the RESU (regional epidemiology and surveillance unit) in morbidity week 23 to week morbidity week 32 despite the intensification of all control and prevention interventions. (Annex C)

WHEREAS, the city of Calbayog was reported to have 1 death secondary to dengue and we cannot predict if cases will progress to become dengue hemorrhagic fever and dengue hemorrhagic shock, which is fatal, it is then imperative that the number of cases be lowered immediately to prevent loss of life

WHEREAS, the extent of affectation of the barangays has continuously expanded and has gone beyond the limits of the urban areas with a total affectation of 51 barangays and 18 amongst these barangays are having clustering of cases.

WHEREAS, the NDRRMC memorandum order no. 60 dated June 17, 2019 allows the declaration of an outbreak and state of calamity when there is extremely high incidence of certain disease whether communicable or non-communicable in a specific period of time, specific health related behavior and other health related events clearly beyond normal expectancy" and "when there is disruption of services.

WHEREAS the declaration of an emergency would enhance collaboration and coordination with the different agencies in the city and would direct the attention of the stakeholders to intensify all preventive and control measures for dengue to affect a lowering of cases

WHEREAS the declaration of a state of calamity would allow the mobilization of the local government unit's quick response fund and likewise that of the barangays to strengthen the logistical support for the interventions for dengue

THEREFORE, the Local Health Board of Calbayog City recommends the declaration of an outbreak for dengue and endorses this resolution to the CDRRMC.

WHEREAS, the extent of affectation of barangays has continuously expanded and has gone beyond the limits of the urban areas with a total affectation of 51 barangays and 18 amongst these barangays are having clustering of cases;

WHEREAS, the NDRMC Memorandum Order Number 60 dated June 17, 2019 allows the declaration of an outbreak and state of calamity "when there is extremely high incidence of disease whether communicable or non-communicable in a specific period of time, specific health related behavior and other health related events clearly beyond normal expectancy" and "when there is disruption of services";

WHEREAS, the declaration of emergency would enhance collaboration and coordination with the different agencies in the city and would direct the attention of the stakeholders to intensify all preventive and control measures for dengue to affect a lowering of cases;

WHEREAS, the declaration of a state of calamity would allow the mobilization of the local government unit's quick response fund and likewise that the barangays to strengthen the logistical support for the interventions for dengue;

NOW THEREFORE, on motion of Honorable Atty. Eduardo P. Tibo unanimously seconded, the Sanggunian –

RESOLVED, as it is hereby resolved to declare the City of Calbayog under a State of Calamity due to dengue outbreak.

RESOLVED FURTHER, that copies of this Resolution be furnished to HIS EXCELLENCY PRESIDENT FERNDINAND R. MARCOS, JR. at his office in Malacañang and other agencies like the Department of Health (DOH), Government Services Insurance System (GSIS) and other government offices for their immediate action and information.


