Republic Act No. 11293, also known as the Philippine Innovation Act, declared the policy of the State to foster innovation as a vital component of national development and sustainable economic growth. Section 21 of this Act provides for the establishment of the innovation Fund, which aims to strengthen entrepreneurship and enterprises engaged in developing innovative solutions benefiting the poorest of the poor.

In line with this, the National Innovation Council (NIC) through the National Economic and Development Authority (NEDA) announces the Call for Proposals for the 2024 Innovation Grants which will remain open until 31 October 2024.

the Implementing Guidelines of the 2024 Innovation Grant, Programs/Activities/Projects (PAPs) focusing in the following areas shall be eligible for funding: Pre-commercialization, Commercialization or Diffusion of Innovation, Innovation Faculties and Services, innovation Culture Promotion and Capacity Building, and Innovation Policy and Administration. Entities eligible to apply for the Grant includes National Government Agencies (NGAs), Government-Owned or Controlled Corporations (GOCCs), Local Government Units (LGU) and State Universities and Colleges (SUCs).

As a member of the NIC, DepEd supports and disseminates this information for reference and consideration of DepEd Bureaus and Services, Regional Offices, Schools Division Offices and public schools who would like to take advantage of this funding window.
