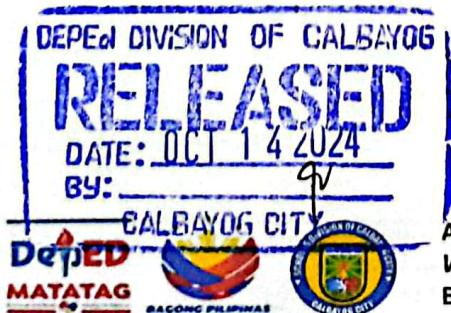

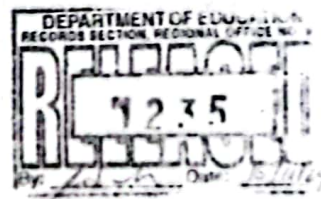

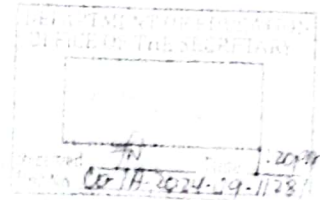

- Attendance shall be on official business.
