- e. Must not be a professional squatter or member of a squatting syndicate as defined by RA 7279 (UDHA).

Documentary Requirements:

- Notarized Application Form (Application forms are available at the District Office located at Brgy. Bagacay, Calbayog City, Samar)
- 2. Government-issued ID/Company ID
- 3. Proof of Civil Status (Photocopy of *Live Birth* for single; *Marriage Contract* for married; *Livebirth and Notarized Affidavit of Cohabitation* for Common-Law Relationship; *Livebirth and Notarized Affidavit de Facto Separation* for de Facto Separation)
- For solo parent, Certification from Municipal or City Social Welfare and Solo Parent ID
- 5. Proof of Income (Income Tax Return/Payslip/Affidavit of Income)
- 6. Certificate of Employment
- 7. Family Picture

NOTE: Only QUALIFIED applicants with COMPLETE documentary requirements will be included in the raffle.
