- 2. The goal of concentration training is to prepare athletes for peak performance in their main competition for a specific sport or event. It also focuses on several key areas:
 - a. improvement of physical fitness;
 - b. acquisition of motor skills;
 - c. enhancement of tactical efficiency; and
 - d. development and improvement of mental capabilities, which includes fostering a positive attitude toward competition, commitment to the sport or event, sincerity and honesty, selfconfidence, optimal levels of aspiration, and the formation of good habits.
- 3. Moreover, the final checking of documentary requirements and onsite interview of athletes, coaches, assistant coaches, and chaperones ensure their qualifications as to their submitted documents through the Regional Screening and Accreditation Committee (RSAC) for 2025 EVRAA Meet
- 4. For the list of participants for this activity, please refer to Enclosures No. 1, 2, and 3 of the Division Memo No. 070, s. 2025 re: Participation of the Calbayog City Athletic Association (CCAA) Delegation to the Clustered Eastern Visayas Regional Athletic Association (EVRAA) Meet 2025.
- 5. Attached is the list of LGU Trainers who shall assist and help our coaches in ensuring the readiness of our athletes to compete in the 2025 EVRAA Meet.
- 6. Participants, athletes, coaches, asst. coaches, chaperones, and trainers, shall bring their sleeping kits, toiletries, water bottle/tumbler, food container and utensils, and other paraphernalia deemed necessary for the duration of the activity.



- 7. Food for all participants, starting dinner on February 11, 2025, shall be charged against the financial assistance received from the Office of the Governor and Office of the Congressman of the 1st District of Samar. However, transportation and incidental expenses of all participants shall be charged against Local Funds/School MOOE/Other funds available subject to the usual accounting, auditing rules and regulations.
- 8. Furthermore, expected participants shall bring their own lunch and afternoon snack on February 11, 2025 since it is NOT yet covered by the food provision as mentioned in item number 7.
- 9. Service Credit (for teachers) or Compensatory Time-Off (for school heads) equivalent to eight (8) hours of service per day shall be granted to the participants who render services on days to that fall on weekends and holidays consistent with the rulings under DepED Order No. 67, s. 1988 and CSC Memorandum Circular No. 09, s. 1988.
- 10. This Memorandum shall serve as the **Travel Authority** of all the identified participants.
- 11. Immediate dissemination of this Memorandum is desired.
