UPDATES ON THE SCREENING AND CERTIFICATION OF DIVISION POOL OF LEARNING FACILITATORS FOR PHASE 2 IMPLEMENTATION OF THE REVISED K-12 CURRICULUM FOR G2358

- 1. In reference to **Division Memorandum Nos. 119 & 143, s. 2025**, informs the field of the updates on the conduct of the Screening and Certification of the Division Pool of Learning Facilitators cognizant to the updates in the **Regional Memorandum No. 287, s. 2025 dated March 12, 2025**.
- 2. There will be screening for new aspirants as Learning Facilitators. They will undergo the following process:
 - a. Session Guide (SG) Writing of the preferred subject area/topics given by the Division Screening Committee;
 - b. Preparation of the Slide Deck (SD) Presentation of the crafted session guide;
 - c. Facilitation Skills Demonstration (using the crafted SG & SD); and
 - d. Behavioral Events Interview (BEI).
- 3. Screening on Session Guide Writing and Slide Deck presentation will be done by the Division Screening Committee while Facilitation Skills Demonstration and Behavioral Events Interview will be conducted by the Regional Screening Committee. The requirements stipulated in Division Memo No. 119, s. 2025 are still to be followed and the pertinent documents will be filed in a long folder. NEAP required forms and templates can be downloaded through bit.ly/formsNEAPLF.
- 4. Certification Process will be conducted to 2018 and 2021 screened NEAP-RVIII Pool of Learning Facilitators (LFs). The concerned LFs will submit the following documents filed in a long folder:
 - a. Photo copy of Certificate of Recognition as LF;
 - b. Hard copy of session guide and slide decks used as LF consistent with letter a;
 - c. Memorandum and Matrix of Activities being facilitated; and


