SUBJECT: DEPED SUMMER PROGRAMS

DATE : April 14, 2025

1. As per DO No. 10, s. 2025 Re conduct of DepEd Summer Programs, the Schools Division Office of Calbayog City through the Curriculum Implementation Division announces the implementation of Deped Summer Programs in all schools in the division effective on **May 13, 2025 to June 6, 2025**, respectively. These programs go beyond mere remediation; they are intended to proactively prepare learners for success in the next school year. Further, these programs shall be thoughtfully designed to align with, complement, and seamlessly integrate into the Academic Recovery and Accessible Learning (ARAL) Program throughout the coming school year, as provided under Republic Act No. 12028.

- 2. Supporting learners in strengthening their foundational knowledge and skills is vital to their success as they move forward in their education journey. Through the following Summer Programs, DepEd aims to reinforce key concepts and skills and empower the learners to enter the next school year with confidence and readiness for new challenges:
- a. Summer Programs for Key Stage 1 (Low Emerging Grade 3 learners who are incoming Grade 4):
 - (1) Literacy Remediation Program
 - b. Summer Programs for Key Stages 2 to 4:
 - (1) Summer Academic Remedial Program; and
 - (2) Regional Remediation Program
- 3. School Heads through the supervision of their Public District Supervisors shall now start scouting teachers who will voluntarily render their services during the conduct of these summer programs. Grade 4 learners and teachers for the Literacy Remediation Program, all grade level teachers whose learners have failing grades in their subjects

for Summer Academic Remedial Program and reading and numeracy teachers willing to advance their non-literate and non-numerate learners under their classes for Regional Remediation Program. Deadline of the submission of the list of learners and volunteer teachers will be on **April 23**, **2025**, Wednesday to be submitted and consolidated per district prior to the submission in the division.

- 4. Trainings are expected to be cascaded among volunteer teachers who are willing to participate in these summer programs before their conduct. Further announcements on this regard will be made once their schedules and venues are laid out.
- 5. There will be an orientation about these Summer Programs scheduled on **April 24**, **2025**, **Thursday** to be held at the Division Conference Hall, **8AM to 5PM**.
- 6. This memorandum will serve as **Travel Authority** of the school head-participants for the orientation.
- 7. Immediate dissemination of and compliance with this Memorandum are desired.
