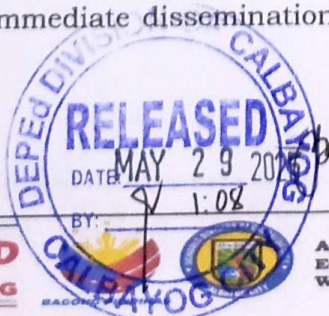



EFFECTIVE SCHOOL YEAR 2025-2026**

1. In reference with DepEd Order No. 88, s. 1997 which outlines guidelines for the establishment and operation of Night High Schools Program (NiHS) and DepEd Order No. 1, s. 2024 which Authorizes the implementation of flexible learning modalities, including condensed curriculum programs for night high schools, provided all learning competencies are met, particularly for those with limited opportunities to attend regular day schools; this schools division formally announces the **"IMPLEMENTATION OF THE FOUR-YEAR NIGHT HIGH SCHOOL CURRICULUM PROGRAM AT CALBAYOG CITY NIGHT HIGH SCHOOL"** effective school year 2025-2026.
2. This transition from previous five-year to four-year program aims to streamline instructional delivery, optimize learning outcomes for working and non-traditional learners, and ensure alignment with national educational standards.
3. The PSDS, school head, teachers with the support of stakeholders shall work collaboratively (such as in planning, resourcing, and program delivery) ensuring effective implementation of the program.
4. Regular division monitoring, and school submission of Program Implementation Report (PIR) to the division and region is required.
5. Attached are the specific guidelines and compressed/consolidated 4-year night high school class program / implementation plan.
6. Expenses relative to implementation of the night school program offerings (to include conduct of orientations, office supplies, and other expenses) shall be charged against respective School MOOE subject to the usual accounting and auditing rules and regulations.
7. Immediate dissemination and strict compliance with this Memorandum are desired.

**SPECIFIC GUIDELINES ON THE IMPLEMENTATION OF FOUR-YEAR NIGHT  
HIGH SCHOOL (NIHS) CURRICULUM PROGRAM OF  
CALBAYOG CITY NIGHT HIGH SCHOOL**

- 
1. **The program is Open to working students, out-of-school youth (OSY), and junior high school (JHS) learners who require flexible schedules.**
  2. The four-year program shall cover **Grade 7 to Grade 10**, with all subjects streamlined to meet the required competencies within a reduced timeframe.
  3. The **enrolment procedure and requirement/s** are the same with the regular day high classes.
  4. **Core Subjects** (English, Mathematics, Science, Filipino , Araling Panlipunan and TLE shall follow the MATATAG Curriculum or Enhanced K to 10 Program guidelines.
  5. **Daily schedule of classes** shall run from 4:30 PM to 9:30 PM, Monday to Friday.
  6. **Instructional Hours:** Minimum of 4 hours daily (240 minutes), with each subject allocated time per DepEd Order No. 12, s. 2024.
  7. **Teaching loads** of teachers shall adhere to DepEd Order NO. 31 s. 2012 (Policy Guidelines on the Implementation of Secondary School Program.
  8. **The Modality is Blended learning:** this include Modular/ online components may supplement face to face classes for learners with work conflicts.
  9. **Night high school students shall participate in curricular and co-curricular activities**, which are activities that are a part of the formal school curriculum. These activities, such as clubs, sports, or other national/regional/division/school-sponsored events, which can foster engagement, improve academic performance, and promote social skills. Participation in **extra-curricular activities are personal and voluntary.**







